Buckingham will partner with Butler Till on a five-story, approximately 106,000 SF mixed use building on Midtown's Parcel 2. Butler Till will occupy two + floors or approximately 47% of the building. The first floor will be allocated to retail and the top two floors will be a mix of market rate and affordable residential units. This project is critical to the continued development and the revitalization of downtown Rochester. Butler Till has committed to bringing approximately 140 FT employees to the new site and is estimating an additional hiring of 78 FT employees.
