Project Description

The company is requesting agency assistance to renovate and modernize a vacant and functionally obsolete structure which has been "off the books" for over a decade. This triangular-shaped shell building located at 90 South Clinton Ave in the City of Rochester, NY consists of approx 2867 disjointed square-feet over four-floors.

The property presents use and operational challenges due to its original intent as a vertical pedestrian transportation hub. The building is devoid of all utilities (sewer, water, gas) except electricity and lacks restrooms. It's location is designated as a highly distressed area per census tract data.

The company intends to develop the facility into a crucial element of the Midtown vision. The operation will be conveniently accessible to the Midtown district due to it's direct connections to Xerox Tower, Legacy Tower, Tower 280 and Parcel 2, as well as other points-of-access from Midtown Garage.

During the day (Monday through Saturday) the company will operate as a food and beverage cafe providing patrons with a functional Co-Work Space with free high-speed Wi-Fi internet. By adding bathrooms, comfortable seating, charging stations and high-quality lighting, the building will become a key amenity for the surrounding community.

On Thursday, Friday and Saturday afternoons, the company will offer a place for workers and residents to meet to network and exchange ideas in a comfortable and safe environment.

- (c) For refunding outstanding COMIDA bond issues, the fee shall be one-quarter percent (1/4%) of the new issuance amount.


3. If a sales tax letter is required prior to closing, a non-refundable twenty-five percent (25%) of the Administrative Fee and Agency Counsel fee is payable at that time. This amount will be applied towards the Administrative fee and Agency Counsel Fee. The Sales Tax Letter shall only be for a three (3) month period.
