Fairport JRM, LLC is constructing a mixed-use building at 1669 Pittsford-Victor Road, Parinton, New York, which has been undeveloped and vacant for over ten plus years. Fairport JRM, LLC intends to construct a +/- 20,000 sq foot building and, as required the New York State Department of Transportation, install a new traffic light along Pittsford-Victor Road.

This application is for +/- 13,600 square feet of space to be leased by the University of Rochester, which will operate an urgent care facility, pediatrics facility, and lab draw station to service the surrounding community. The University of Rochester intends to hire 15 employees for this facility (12 full time and 3 part time). The University of Rochester's proposed facility is particularly unique because it will encompass an urgent care, pediatrics facility, and a lab draw station all in one location. Typically, patients would have to visit two or more facilities to take advantage of all of the services that will be offered in this one location. The facility will also have a designated space for ambulance pick-ups and drop-offs.

Other tenants will include Reeds Jewelers (5,600 square feet) and a proposed restaurant (2,970 square feet) However, any real property tax abatement would be passed on only to the University of Rochester.

**2. Administrative Fee - Paid at Closing**

- (a) For tax-exempt IRB bond issues, the fee shall be one percent (1%) of the project amount. For projects that utilize a Payment In Lieu of Taxes (PILOT) agreement, an additional one-quarter percent (1/4%) will be added.
- (b) For lease/leaseback transactions and taxable bond issues, the fee shall be one-half percent (1/2%) of the project amount. For projects that utilize a Payment In Lieu of Taxes (PILOT) agreement, an additional one-quarter percent (1/4%) will be added.
- (c) For refunding outstanding COMIDA bond issues, the fee shall be one-quarter percent (1/4%) of the new issuance amount.

3. If a sales tax letter is required prior to closing, a non-refundable twenty-five percent (25%) of the Administrative Fee and Agency Counsel fee is payable at that time. This amount will be applied towards the Administrative fee and Agency Counsel Fee. The Sales Tax Letter shall only be for a three (3) month period. If the project does not have a formal closing within three (3) months of the sales tax letter being issued, and an extension is not granted, the balance of the Administrative fee and Agency Counsel fee become immediately due and payable.

4. Agency Counsel fee is one-third (1/3) of the Agency's Administrative fee, with a minimum fee for a lease/leaseback transaction of \$4,000.00.
