Project Description:
Following a tragic fire of the Sherwood Shoe Factory and post 490 expressway construction the DOT owned this property and used it as equipment storage. Purchased from the DOT in 2015 the developer worked closely with the neighborhood associations to design a building in-keeping with the neighborhood, with modern day conveniences and amenities. Post phase II environmental assessment investigations led The Developer to realize the extent of environmental contamination and the need to remediate such. Subsequently being accepted into the New York State Brownfield program, the developer is proposing to clean the site and develop a 100 unit, wood & masonry framed multi-family residential building. The units will include studios, 1 bedroom and 2 bedroom apartments, 20% of which will be "Affordable" for households earning 60% of the area median income. Unique to the neighborhood and the city this building is a one-of-a-kind environmentally friendly structure with a full suite of roof-top solar array capable of producing approximately 340,000 kWh's on an annual basis. Coupled with LED lighting throughout, state-of-the-art HVAC system, live-work office cubes this building should set the tone for future sustainable development in New York State.



2. **Administrative Fee - Paid at Closing**

- (a) For tax-exempt IRB bond issues, the fee shall be one percent (1%) of the project amount. For projects that utilize a Payment In Lieu of Taxes (PILOT) agreement, an additional one-quarter percent (1/4%) will be added.
 - (b) For lease/leaseback transactions and taxable bond issues, the fee shall be one-half percent (1/2%) of the project amount. For projects that utilize a Payment In Lieu of Taxes (PILOT) agreement, an additional one-quarter percent (1/4%) will be added.
 - (c) For refunding outstanding COMIDA bond issues, the fee shall be one-quarter percent (1/4%) of the new issuance amount.
3. If a sales tax letter is required prior to closing, a non-refundable twenty-five percent (25%) of the Administrative Fee and Agency Counsel fee is payable at that time. This amount will be applied towards the Administrative fee and Agency Counsel Fee. The Sales Tax Letter shall only be for a three (3) month period. If the project does not have a formal closing within three (3) months of the sales tax letter being issued, and an extension is not granted, the balance of the Administrative fee and Agency Counsel fee become immediately due and payable.


