Panorama Landing is a 20.92 acre parcel located on the West side of Panorama Trail South. Acquired in December 2015 by Panorama Landing, LLC for \$1,500,000, the parcel will be developed to accommodate five single story office buildings and be served by private utilities and a private entry road. Phase 1 approval has been obtained and includes construction of the entry road, site improvements and construction of the first three buildings. To date, the road is installed, the improvements are in for the first three lots, construction of Building A (14,000 SF) is complete with 100% occupancy and the shell of Building B (24,000 SF) has been completed. At this point we are requesting sale and mortgage tax exemptions for the balance of the previously approved Phase 1 costs, to include build-out of Building B and shell construction and build-out of Building C (24,000 SF). The remaining construction budgets are as follows:



**2. Administrative Fee - Paid at Closing**

- (a) For tax-exempt IRB bond issues, the fee shall be one percent (1%) of the project amount. For projects that utilize a Payment In Lieu of Taxes (PILOT) agreement, an additional one-quarter percent (1/4%) will be added.
  - (b) For lease/leaseback transactions and taxable bond issues, the fee shall be one-half percent (1/2%) of the project amount. For projects that utilize a Payment In Lieu of Taxes (PILOT) agreement, an additional one-quarter percent (1/4%) will be added.
  - (c) For refunding outstanding COMIDA bond issues, the fee shall be one-quarter percent (1/4%) of the new issuance amount.
3. If a sales tax letter is required prior to closing, a non-refundable twenty-five percent (25%) of the Administrative Fee and Agency Counsel fee is payable at that time. This amount will be applied towards the Administrative fee and Agency Counsel Fee. The Sales Tax Letter shall only be for a three (3) month period. If the project does not have a formal closing within three (3) months of the sales tax letter being issued, and an extension is not granted, the balance of the Administrative fee and Agency Counsel fee become immediately due and payable.
4. Agency Counsel fee is one-third (1/3) of the Agency's Administrative fee, with a minimum fee for a lease/leaseback transaction of \$4,000.00.
5. Designated Bond Counsel fee is based on the complexity and amount of the transaction.

- D.
