SimuTech Group, Inc. sells engineering simulation software and also provides engineering consulting and testing services. SimuTech has roots dating back over 35 years with 20 year locally. SimuTech is an international company with offices across the United States and Canada with our current headquarters located in Rochester, NY. SimuTech serves customers from various industries including (not limited to) Aerospace, Automotive, Defense, Energy, Healthcare and Industrial Equipment. All of SimuTech's 116 employees (24 locally) are professional salaried positions. SimuTech currently leases approximately 8,500 sq ft in the Town of Henrietta. The plan for SimuTech's new headquarters is an approximately 14,500 sq ft building that will be located on 3 acres in Panorama Park in the Town of Penfield. The company's current facility is outdated and does not portray the high tech image needed for the engineering software and services industry. We have also reached our current buildings capacity and need a new headquarters to continue the company's growth locally. The new headquarters will now be our training hub for customers across the US and Canada as well as a training facility for new and existing employees. We believe our new headquarters will give us a competitive advantage over our competitors in terms of selling our training services and in terms of recruiting new talent which has been a challenge in a tight labor market. SimuTech's immediate hiring needs include engineering, sales, IT and human resources in order to properly service our expanding base of customers and to support continued growth.

2. Administrative Fee - Paid at Closing

- (a) For tax-exempt IRB bond issues, the fee shall be one percent (1%) of the project amount. For projects that utilize a Payment In Lieu of Taxes (PILOT) agreement, an additional one-quarter percent (1/4%) will be added.
- (b) For lease/leaseback transactions and taxable bond issues, the fee shall be one-half percent (1/2%) of the project amount. For projects that utilize a Payment In Lieu of Taxes (PILOT) agreement, an additional one-quarter percent (1/4%) will be added.
- (c) For refunding outstanding COMIDA bond issues, the fee shall be one-quarter percent (1/4%) of the new issuance amount.

3. If a sales tax letter is required prior to closing, a non-refundable twenty-five percent (25%) of the Administrative Fee and Agency Counsel fee is payable at that time. This amount will be applied towards the Administrative fee and Agency Counsel Fee. The Sales Tax Letter shall only be for a three (3) month period. If the project does not have a formal closing within three (3) months of the sales tax letter being issued, and an extension is not granted, the balance of the Administrative fee and Agency Counsel fee become immediately due and payable.
